

### Village of Corfu Committee Meeting February 12, 2020

The Village of Corfu Board of Trustees held its Meeting at the Corfu Village Hall, 116 East Main Street on February 12, 2020, at 6:30 p.m.

Present: Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Village Clerk, Jennifer Eck, Camden Group Representative, Glenn Eck, M&T Bank Branch Manager, Scott Maciejewski. Absent: Mayor Sargent.

The meeting was opened at 6:30 pm followed by the Pledge to the Flag.

#### Planning Board Update:

- Trustee Reisdorf and Trustee Doktor held the first Beautification Committee meeting at the Corfu Library on Feb. 6, 2020; 12 residents of various communities attended.
- It was decided a "blanket" committee should be created as this is not a committee to specifically to beautify the Village. This committee will cover beautification, farmer's market, and events throughout the Village.
- Trustee Reisdorf requested that the Village help with postage and copies to start the process; he will follow up with email communication thereafter.
- Trustee Doktor discussed the 5013C filing that will need to establish the accounts for this committee; Ron Long mentioned the committee would be able to use his filing if needed.

NATIONAL GRID LED STREET LIGHT CONVERSION

WHEREAS, National Grid is offering a LED Street light conversion program that will convert all of the Village of Corfu Street lights from high pressure sodium to energy saving LED street lights, and

WHEREAS, the Village is part of the Town of Pembroke and said Town has an adopted Comprehensive Plan that recommends energy conservation measures, and

WHEREAS, a review of those proposals showed the National Grid Proposal to be the most beneficial program (see attached), and

NATIONAL GRID New Street Light Request

7 Maple Ave, Corfu, NY 14036

WHEREAS, National Grid currently owns and maintains all the street lights in the Village of Corfu, and

WHEREAS, the Village of Corfu has had requests from the Corfu Free Library and other individuals to increase the street lighting in front of 7 Maple Ave, Corfu, NY 14036 for the safety of both pedestrians and motorists, and

WHEREAS, a review of the area by members of the Village of Corfu Board confirms that additional street lighting would improve the safety of the area, and

WHEREAS, representatives from National Grid have asked the Village of Corfu to put forward a resolution requesting National Grid provide an estimate of the cost installing a new street light onto the National Grid pole numbered NG 9378 3 located directly across from 7 Maple Ave, Corfu, NY 14036, and

WHEREAS, representatives from the Village of Corfu estimate the desired LED wattage to be C48 to be placed on an arm of approximately 12 feet, and

WHEREAS, the Village of Corfu would like this light to be placed on the Village of Corfu National Grid account number XXXXX, and

NOW THEREFORE BE IT RESOLVED, the Village of Corfu Board hereby requests National Grid to put forward a cost estimate to place an LED street light on National Grid pole numbered NG 9378 3 located directly across from 7 Maple Ave, Corfu, NY 14036.

- Deputy Mayor Graham Informed Board that the gas line has been installed on Fieldcrest; possibly hooking plant up
