



## Village of Corfu Committee Meeting Minutes February 23, 2022

The Village of Corfu held its Committee Meeting on February 23, 2022, at 6:30 p.m. at Town of Pembroke Community Center room located at 116 East Main St, Corfu NY 14036. In attendance: Mayor Sargent, Deputy Mayor Doktor, Trustee Lauer, Trustee Reisdorf, Trustee Johnson. Also in attendance, Village Clerk, Jennifer Eck, and Officer in Charge, David Krezmien, Officers Givens and Lang, Brandon Moore (Police Officer Candidate) and Steven Flumerfeldt (Zoning and Code Enforcement Candidate).

### Police Update:

- Mayor Sargent introduced Brandon Moore who has applied for the open Police Officer position. Mr. Moore addressed the Board of his experience and training. Officer Krezmien explained the background screening the department has completed for all potential candidates.
- Officer Krezmien discussed with the Board the department is preparing for a verbal state audit, the state is reviewing all procedures and general orders.
- The Board asked if there was a way for information to be distributed to the Board on incidents that happen. Officer Krezmien explained that not all incidents happen with the Village Police Department, and he wouldn't have all pertinent information for the Board.
- Mr. Moore and the Corfu Police Department Officers left the meeting.
