

Village of Corfu Committee Meeting Minutes February 24, 2021

The Village of Corfu Board of Trustees held its Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on February 24, 2021 at 6:30 p.m. Present were Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Village Clerk, Jennifer Eck, Officer in Charge, David Krzemien. Mayor Sargent was absent.

Planning Update:

- Trustee Reisdorf spoke with Planning Board Chairman, Mark Zimmerman regarding Schmeigel property; waiting on survey to see where they want the border for the rezoning line
- Trustee Reisdorf informed the Board that 18 East Main Street is now completed

Police Update:

- Officer in Charge, David Krzemien addressed the Board on policies that have been established within the department and how he has seen a change in the Officers moral and helping each other
- Officer Krzemien is working with Genesee County and Erie County on the computer systems,
 working on a plan to integrate a more user-friendly system
- Compliance with DA office is the best in the county
- Crown Vic is out of service; approx. \$3,500 in repairs needed; Officer Krzemien explained that this vehicle is costing the Village a lot of money in repair costs
- Police garage is in need of water supply
- Deputy Mayor Graham discussed the gate at the plant and need to get the Officers to close/lock gate when leaving garage
- Officer Krzemien is working on establishing office hours and would like to have them posted on our website
- The Police Department will be holding quarterly meetings; Officer Krzemien welcomed the Board to attend; March 21st at 10am
- Officer Krzemien left meeting at 7pm

 Trustee Doktor discussed with the Board that the trailer that has been requested by the maintenance department requires preorder to be scheduled for delivery in August
