

Village of Corfu Committee Meeting February 26, 2020

The Village of Corfu held its Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on February 26, 2020 at 6:30 p.m.

Present: Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Doktor, Trustee Reisdorf, Village Clerk, Jennifer Eck and Officer Patrick Reeves.

The meeting was opened at 6:30 pm followed by the Pledge to the Flag.

Police Update:

- Officer Reeves was requested to attend the Village Board Meeting to discuss the opportunity to purchase tasers for the Village of Corfu Police Department
- Officer Reeves reviewed with the Board the procedures used in various authorities with the Taser equipment and how effective this equipment is
- Approximate cost of the unit would be \$1,000 with a need for extra cartridges (approx. \$28) and holsters; there is training required (8-hour class/ Genesee County offers said training)
- The Board reviewed the Standard Operating Guidelines for the Electronic Control Weapons;
 Officer Reeves recommended our Attorney to review the procedures
- Mayor Sargent reached out to attorney for the compensatory time; the Mayor was informed the compensatory time is not an option for the Department at this time

Maintenance Update:

- Charlie Lenhard inquired about the clean up of snow in front of the Bank to the curb
- Mayor Sargent and Trustee Doktor will review the streetlights throughout the Village to decide on the which lights will need the shield and the lumens needed per light

Court Update:

- Trustee Reisdorf and David Saleh have completed and created a report regarding the Court Audit
- Trustee Reisdorf presented the Board with the Report for review; any concerns after the review of the records have been explained or corrected; Prosecutor to dismiss old cases

Sewer Update:

- The Clarifier Drive (gearbox) broke; Bailey's is working on the repair
- The New Sewer Plant project is underway
- Village Clerk, Jennifer Eck has completed the information need for the UV Light Grant; Deputy
 Mayor Graham commended Jennifer on the completion of the project
- National Fuel Gas will be reviewing the specifications of the lines on Fieldcrest and review if there will be enough volume to supply both plants
- Deputy Mayor Graham will contact Highway Superintendent to discuss new address

Planning Update:

- Beautification Committee meeting scheduled for Thursday, March 5, 2020 at the Library
- Trustee Reisdorf met with Ron Long; Mr. Long offered his property for farmer's market

- The Board reviewed the wages for the Election Officials; the Board would like to increase the fee to \$110 for this year's elections for March
