Clerk presented paperwork with operating logs from Yancey's Fancy to Trustee Graham, with questions for sewer billing from Deputy Clerk Beal. He explained that the PM readings were in addition to the regular readings and would only be short term.

Trustee Graham also updated the Board on the Main Lift station part that had been discussed at a prior meeting. He said they found out the part itself was out of warranty, but the panel box was what had failed causing the part to short out. He said the panel box was under warranty, so the situation is still under review.

Trustee Graham informed the Board that he had spoken with Superintendent Worth from the Town of Pembroke regarding the Sewer Agreement. He said Superintendent Worth was uncomfortable with the language about reserving the right to change industrial rates. Superintendent Worth felt it would be more of an enticement to businesses if that language was not in the Sewer Agreement. Trustee Graham suggested as an alternative to include the language in the Sewer Use Law and permits. It was added that it is the Village's decision on who is in our sewer and what fees we charge in the Sewer Use Law. Motion was made by Trustee Graham and seconded by Trustee McMartin-Eck to remove the language regarding Commercial/Industrial rates in the Town of Pembroke Sewer Agreement.
