

Village of Corfu Committee Meeting Minutes March 23, 2022

The Village of Corfu held its Committee Meeting on March 23, 2022, at 6:30 p.m. at Town of Pembroke Community Center room located at 116 East Main St, Corfu NY 14036. In attendance: Mayor Sargent, Deputy Mayor Doktor, Trustee Lauer, Trustee Johnson. Also in attendance, Village Clerk, Jennifer Eck, and Village Electrician Norman Waff and Felipe Oltramari from Genesee County Planning Board. Trustee Reisdorf was absent.

Felipe Oltramari, Genesee County Planning Board addressed the Board the procedural changes to the Genesee County Planning Board requirements. The Village and Genesee County can enter into an agreement that the Village can made decisions on minor residential projects, without sending the documents to Genesee County for approval. This will help in resolving delays for residential projects. There is an item listing of 14 items the Village planning board can approve. Mr. Oltramari discussed that the Commercial State Regulations or emergency services and issues the County does have to approve.

Mr. Oltramari left the meeting at 6:40 pm.

Planning and Code Enforcement Update:

- Steven Flumerfeldt has decided not to take the Code Enforcement and Zoning Officer position due to the number of hours needed for the classes to be approved for the position.
- The Board discussed what they can do in the meantime until an Officer is appointed. Possibly reaching out to Town of Pembroke for assistance.
- Received permit from the bank. The need for a door to access the ATM is required to be installed.
- Liquor store still need final inspection. Town of Pembroke inspector had a list of items needed to be finished before final inspection.
- Trustee Lauer recommended the Village adopt Town of Pembroke's Fee Structure for permits.

- Mayor Sargent and Deputy Mayor Doktor have a meeting next week to discuss Police Contract.

- Notice of Relevy letters have been sent out for unpaid sewer invoices due 4/11/22 to avoid relevy on Village Property tax.
- Discusses ARPA funds and reporting Discussed what the different projects could be. Reporting of funds needs to be reported in April, however, projects can be done up until 2024.
- Trustee Lauer discussed with the Board having MRB research grant options for alternative energy and water drainage on route 77. Reviewed safety issues the Mr. Waff had brought up to the Board at the plant, possibility of a homeland security grant. Mayor Sargent and Trustee Lauer will discuss with MRB.
