

Village of Corfu Committee Meeting Minutes March 24, 2021

The Village of Corfu Mayor and Board of Trustees held the Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on March 24, 2021 at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Camden Group Representative, Glenn Eck, Officer in Charge, David Krzemien. Village Residents, Tyler Mutka and Keith Mutka.

Planning Update:

- Trustee Reisdorf discussed a site plan review has been submitted for the liquor store.
- Also submitted 10 East Main Street review for Nick Rada
- Mayor Sargent stated Annual Report needs to be completed by Zoning and Code Enforcement Officer by April 1st

Police Update:

- Officer in Charge, David Krzemien addressed the Board on the Police Department
 - o 151 shifts completed.
 - The Department has a full roster for March.
 - 427 Summons were issued in Village, 459 Businesses checked, 941 call, 39 Community Police events, 11 Police reports, 9 shared services (7 in Town of Pembroke, 2 in Darien), 47 Dispatched calls in Village.
 - o Department will bring on earlier shifts 3am-7am
 - o Arrests made in Sterling Tent break-in
 - Officer Krzemien explained to the Board a couple calls they have had that put the Officer's and residents in jeopardy. The Department could have used force, and feels that a taser, would be an asset to the Officers.

- o Received 3 resignations; working on hiring 2 more Officers along with Trainee.
- Received equipment from one Officer that has resigned, working with Union to retrieve equipment from a different Officer.
