It was mentioned that due to the stalled Union negotiations, officer salaries cannot be changed.

Clerk was also requested to find out how much anticipated additional revenue may be expected in Sewer by the addition of the TA Truck Stop and to adjust the budget accordingly.

Motion was made by Trustee McMartin-Eck and seconded by Trustee Lauer to agree to 2% increase in salary for the Clerk, Deputy Clerk, Court Clerk and Maintenance.
