Members Present: Trustees Graham and McMartin-Eck. Also present were newly elected Trustees Ken Lauer and Joseph Biggs Johnson, Jesse Stocking of Village Maintenance and resident Linda Tucker. Mayor Bielec was absent.

Clerk Thomas administered Oath of Office to Ken Lauer and Joseph Biggs Johnson as Trustees for two years from 4/4/16 - 4/3/18.

Clerk read an email from Mayor Dave Bielec appointing Trustee Johnson as Deputy Mayor. Deputy Mayor Johnson opened the Annual Organizational meeting at 6:35 pm, followed by the Pledge of Allegiance.

Deputy Mayor Johnson opened the Public Hearing for the budget at 6:37 pm.

Resident Linda Tucker presented some questions regarding the budget to the Board. She questioned the decrease in personal service amount and increases in the equipment and contractual line items budgeted for the Police department. The Board explained the personal service reduction was partially due to no-shows by some of the Police personnel and based on hours projected for the coming year. The Board also mentioned that increases in Equipment and Contractual were based on the pending Police Union contract specifying that one of the vehicles will need to be replaced and additional training and other items that are included in the pending contract.

Ms. Tucker questioned where the Police contract stands at this time. The Board informed her it is now in the hands of the Police Union to be ratified. She also mentioned a concern regarding the police officers parking at the cemetery in a manner that blocks the south entrance to the cemetery. Board members said they will speak to the officers.

Ms. Tucker also questioned the sewer revenue permit fees and the Board updated her on the source of the fees. Ms. Tucker said she had no further questions at the time.

The Board also briefly talked about the status of TA Truck Stop with regard to hooking into the sewer system. Trustee Graham informed the Board that things are now moving along and part of the hold-up had been that they needed to hire their own Engineers for the project.

Jesse Stocking spoke to the Board regarding replacement cost for the sidewalk machine/mower. He mentioned that State bid price has been increasing on a regular basis and the current price is only good for a very short time before another increase. He said he has priced out the machine 3 times already. He also said there is a 3 month lead time for delivery so in order to lock in the current price the machine would need to be ordered right away for delivery in June or July.

Mr. Stocking presented figures based on utilizing a portion of the Chips funds that were unused for 2015-16 fiscal year and a portion of the 2016-17 Chips funds. He also anticipates being able to sell the old machine for at least \$10,000 to utilize towards the new machine. He did mention they would need to keep the old one until the new one comes in

so he would still have a machine to use in the interim, so would not be able to put it out for bid right away. The Board discussed the matter briefly.

Trustee Lauer gave the Board an update on the meeting he had recently attended on the Summer Youth Program. Trustee Lauer questioned by removing "residential" the Village may be unable to recoup costs incurred for additional treatment and time for the non-residential users. Trustee Graham pointed out that the additional lab work and/or additional treatment required for Industrial or commercial users is covered by the Sewer Use Law and the additional permit and lab fees that they are charged separately from the usage fees. He stressed that the Sewer Use Law supersedes the Agreement between the Village and Town per the NYS DEC. It was also mentioned that the commercial and industrial users are subject to overage fees if they exceed the allotted amount of flow specified in their permit.
