

Village of Corfu Committee Meeting April 22, 2020

The Village of Corfu held its Monthly Committee Meeting via telephone conference April 22, 2020 at 6:30 p.m. (copy of voice recording attached)

Present: Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Village Clerk, Jennifer Eck and Camden Group Representative, Glenn Eck, resident Ann Geophart.

The meeting was opened at 6:30 pm followed by the Pledge to the Flag

Planning & Code Enforcement:

- Trustee Reisdorf informed the Board the Farmer's Market tentative kick off date will be Monday, June 1, 2020 at the Village Offices' parking lot; the Farmer's Market Board might speak with the school to see if there parking lot is available due to the conflict of the Fire Dept's Monday night drill
- Fee to participate in the Farmer's Market will be \$25 per week or \$100 for a 6 week commitment; Village Clerk is helping with the payments for Market and flower pots and will call M&T Bank regarding if a separate checking account is needed for this committee
- Mark Zimmerman sent the Board links that Shane and Dillon Hale have worked on for the website; every business in the area is on the links and they included a community bulletin board on the page for residents to know what is going on.
- Mayor Sargent pointed out the phenomenal job that Shane and Dillon have done with the website; all members of the Board expressed their gratefulness for their dedication to this project.

- Officers that are currently working have been helping to pick up supplies for the local Food

- Mayor Sargent expressed his gratitude for these Officers going above and beyond their normal duties to help our community

Court Update:

- Court is still closed through the end of May
- Court Clerk did come in to sort the mail; however, per NYS she cannot upload the tickets or make any type of deposit from tickets

Maintenance Update:

- Delivery of the Ford 550 Dump truck is scheduled for delivery in August 2020
- Weather permitting the Maintenance Department is picking up brush on Mondays & Fridays
- Discussed drainage ditch along Railroad bed; Deputy Mayor Graham explained to the Board that this was last completed with the Village wide drainage project
- The Board questioned when the ditch and creek bed could be done; Deputy Clerk will reach out to Paul Chatfield for grant research on this project
