Planning & Code Enforcement:

- Reviewed letter from Ken Lauer, Buttercrumbs Bakery regarding property condition at 11 East Main St and the landscaping issues after National Fuel completed work at 11 East Main Street and 13 East Main Street; Mayor Sargent will reach out to Tillman Asphalt to review areas in need of repair

Police Update:

- Officer in Charge, Mr. Krzemien discussed the current statistics of the police department.
 - o More community policing
 - 2 investigations being conducted
 - More shifts are now covered
 - Discussed extending probation period for an Officer due to more training required, Genesee
 County Sheriff's have been helping
 - Working on policy for SRO training for active shooter this summer

Mr. Waff's Report – Maintenance / Sewer

- FCC license still in progress
- Photo inventory still in progress
- Down spout splash blocks are ordered
- Gas cans for mixing fuel for the 2 cycle equipment have been purchased
- Material for overhead door repair in the South Maintenance Building has been purchased and delivered
- Concrete flat work behind police garage must be completed by the last week in August to allow for curing – Mayor Sargent will work on quote for project
- Need arrangements to purchase 93 octane Speedway does carry this
- Mr. Waff is building a mezzanine in the north end of East Drying Bed for winter storage of planter boxes Mr. Waff will work on the quote of supplies
- The rear gate will be locked next week
- Anti-jimmy device has been installed on the South Shop man door
- Mr. Waff inquired on plant #2 issues Mayor Sargent will reach out to Town of Pembroke
 - Influent Room door does not latch, safety concern
 - Blower Room door does not latch
 - Control Room and blower room neither have emergency/night light fixture installed, there is no night light fixture – per designs; blower room is windowless.
 - o Electric panel in filter building status? Per Mr. Graham it was decided not to be moved
 - Would like to see water to Police garage once the UV light project starts
 - Discussed the need for WET stamping on all future plans for plant

- Deputy Clerk has completed the Zoning Law Book so we now have in electronic format
