Mayor Johnson opened the Regular Board meeting at 6:33 pm, followed by the Pledge of Allegiance. Board members reviewed bills to be paid.

Members present: Mayor Johnson, Trustees Lauer, Graham, Sargent and McMartin-Eck. Also present were Town Superintendent John Worth, Mark Masse from GCEDC and Glenn Eck of Camden Group.

John Worth and Mark Masse were there to address the Board regarding the potential addition to the sewer plant. Copies of an "Amendment to the Agreement for Sanitary Sewer Service" were given to Board members. Superintendent Worth said it would provide an opportunity for growth and in the long run potentially lower sewer rates. Mayor Johnson questioned with the additional flow if they would vary the rate between the Village and the Town. Superintendent Worth said residential rates should remain the same between the districts but in the Amended agreement there is a section that indicates that commercial rates may vary.

Trustee McMartin-Eck questioned who would own the plant addition. She was informed that the Town would be the investor and provide the funding, and that negative issues would fall on the Town. Regarding DEC permits it was mentioned that the plants could be hooked together before disinfection and treatment or have two separate disinfections before it goes to the creek. Disinfection is now required by the DEC. With single outflow they would automatically install the disinfection. If they consider two outflows, the Village will be required to put in disinfection, so with the single outflow valving will control the inflow and the force mains will have valving.

The Board was informed that currently they are doing the pre-engineering and SEQR. DEC determines the limits. The next step would be to look at the design and engineering. The permit would be different. It is currently for a flow of 135,000 gallons. With the additional plant they are looking at 300,000 gallons with a potential of going to 450,000 gallons in the permit. Trustee McMartin-Eck said she would like our engineers to look the plans over to protect the Village. If they do would the Village pay the expense or the Town cover it?

Superintendent Worth said that currently with Yancey's and Kutters as well as other Pembroke users the Town capacity is approximately 60% of the flow. They are expecting 80,000 to 90,000 gallons by the end of next year, especially with Yancey's expansion. He said by going bigger it reduces the cost for future expansion that may be needed.

Superintendent Worth was questioned why the term of 30 years was set as the term of the Amendment Agreement. He said it was because the life expectancy of the plant is about 30 years. John Worth and Mark Masse left the meeting at 7:24 pm.

Clerk presented paperwork received to name the Town of Pembroke as Lead Agency for the WWTP Expansion. Brief discussion took place.
