Deputy Mayor Bielec opened the Committee meeting at 6:35 pm in the absence of Mayor Peterson. The meeting began with the Pledge of Allegiance.

Mr. Floss reviewed some of the coverage items listed in the summary he had put together including explanation of blanket coverage of tools and equipment not shown on the individual equipment listing. He gave a brief description of flood, earthquake, pollution coverage, cyber liability etc.

Mr. Floss also mentioned there are currently two open claims; one regarding employee theft and a second one filed by Mayor Peterson on April 17, 2013 regarding a potential lawsuit by Police officers regarding Civil service status and back pay. Mr. Floss was informed to include the Village office and Board on any potential claims or communications regarding any changes in the policy.

Clerk Thomas mentioned that when inquiring into the potential increase during budget time, she was given a potential increase figure and that the total being presented today is over \$1000 higher what had been budgeted per those figures. Mr. Floss said he will mail enough copies of the summary for all the Board members and if there are any changes that Board feels should be made to let him know and he will work with the Village. He did mention that part of the additional increase was due to an increase in management liability which was increased throughout New York State.

Mr. Floss left the meeting at 6:52 pm.

Dear Mayor Peterson,

I am writing to you today at the direction of the Village Board to seek your resignation as Mayor of the Village of Corfu. This written resignation is to be presented to the Village Clerk no later than 5:00 pm on Friday, August 23, 2013.

The Board's decision to seek your resignation is a direct result of numerous intentional acts by you in your capacity as mayor that are contrary to the best interests of the Village of Corfu and its residents. The motivation for these actions can only be construed as furthering your own interests and not those of the Village Board or the taxpayers you serve.

These actions include but are not limited to your general pattern of obstruction and interference with the Village Board's efforts to hold Judge Robert Alexander and his daughter, Brandi Watts, accountable for their actions during their tenure in the Corfu Justice Court and to recover the funds missing during that timeframe. It is clear that your relationship with the judge has influenced many of your decisions in this matter.

Further evidence of your obstruction and egregious interference with Village business is your intentional concealment of the existence of a letter to you from an attorney representing a number of Corfu Police officers dated May 3, 2013 offering to resolve their threatened lawsuit for \$15,000 plus \$1,500 in attorneys' fees. The existence of this letter was only discovered at the meeting held on Monday, August 12, 2013, despite numerous inquiries by Board members as to the status of the threatened action in the intervening months.

During the meeting of August 12<sup>th</sup>, you were asked why neither the Board nor the attorney for the Village were made aware of the letter. You stated to the Board and to me that you intentionally concealed this letter from the Board hoping that the Police Officers would sue the Village. You also stated that it was your hope that the matter would then be referred to the Village's insurance company and that the claim for back wages would be paid.

Your actions in this instance reveal your attempt to disparage the former police administrator and the prior Village administration. Your actions assisted the police officers in their efforts to recoup "lost wages" despite overwhelming evidence that they were not entitled to those wages. These actions are all contrary to the best interests of the Village and are in furtherance of your own personal agenda.

During your tenure as mayor you have made threats to the owner of the company under contract to operate and maintain the Village Sewer Plant (Camden Group). You threatened that if the owner did not remove his employee Al Graham from the position of manager of the Corfu sewer plant that you would see to it that their contract would be terminated. This is another example of furthering your own self interest at the expense of the Village because Al Graham is the former deputy mayor of the Village of Corfu with whom you have had long standing differences.

Furthermore, you have engaged in an ongoing pattern of threats, intimidation and harassment of the Village Clerk Sandra Thomas and the Deputy Clerk Denise Beal. Your misconduct was detailed in letters submitted to the Board by the Clerk and Deputy Clerk on July 22, 2013 alleging the harassment and claiming that your actions resulted in the creation of an unsafe workplace for them. Once again your individual actions have created the possibility that the Village will be engaged in litigation.

There are also numerous instances where you abused your authority by hiring police officers, acquiring uniforms and other equipment, and renewing Village insurance policies without prior Board authorization.

When you took office as mayor, you swore an oath to serve in the best interests of the Village residents and taxpayers. Your failure to do so and the actions set forth above give the Village Board of the Village of Corfu no alternative but to request your resignation as mayor before the Village is further damaged.


