



Village of Corfu Regular Meeting Minutes September 8, 2021

Planning/Code Update:

- Home Slice 33 Pizzeria – submitted paperwork to Genesee County Planning Board, waiting for approval.
- Bistro – submitted site plan application to Genesee County Planning Board, waiting on approval with NYS DOT and will need to meet with Zoning Officer

Police Update:

- Received letter of resignation from Officer Scanio.
- Discussed waiting on resignation from another Officer due to the lack of fulfilling status.
- Possibility of 2 concerts left for the Darien Lake season, things have been going smoothly with traffic control.
- Damage to the 2020 Explorer as it has caught a guard rail. Estimate is \$1,942.00 asked the Board whether to turn it into the insurance company or fix without insurance as the deductible is \$1,000. Discussed that possibly can get a cheaper price on the repair.

- Mr. Waff addressed the Board requesting the purchase of a new shop door, the need for new locks on new door and police door, approx. \$200.

- Mr. Eck will place an order for cones for maintenance department

- Mr. Eck sent in the local highway mileage for, Fieldcrest drive is included (for Chips monies)

- Discussed the need to send to homeowner near the post office to have the sidewalk replaced immediately, safety hazard.

Office Update:

- Discussion regarding Jen Wolcott to help with the transition on Deputy Clerk processing accounts payable. Her firm will charge \$75 per hour with an estimate of 4 hours per month. A letter of services will be presented at next meeting.
- Village Clerk and Mayor met with Sheridan Benefits and discussed moving renewals to the fiscal year instead of after the new fiscal year starts.
- Shane and Dillon Hale addressed the Board for a program for our website for having a .gov address. This will help alleviate any issues on cyberattacks etc. Also discussed on whether to google or Microsoft for emails for the Village. Shane & Dillon will research to see which is more beneficial of the 2 plans, both plans are \$6 for each service, per month, per email address.

- Discussion regarding pricing for the Economic Development for dumping and treatment of their waste. Would like this to be dumped at the TA Travel Plaza. After discussion it was decided the Mr. Eck will reach out to Camden to get pricing.
- Yancey’s Fancy has reached out to Mr. Eck to increase their monthly limits to 24,000. Trustee Lauer questioned the current contract; Mr. Eck will bring current and new contract to next meeting.
- Trustee Lauer asked if the task list of the sewer plant has been started yet from Camden Group, Mr. Eck informed Trustee Lauer that has not been completed yet as the old plant is not completely shut down yet.
- Trustee Reisdorf received quotes from Atlas energy for the plant’s electric needs. The Plant is currently going through new wave energy and has the potential of saving \$40,000 over a term of 49 months.

Trustee Lauer made a motion to switch to Atlas energy, once the attorney reviews contracts, 2nd by Trustee Johnson.
