Mayor Johnson opened Committee meeting at 6:33 pm, followed by the Pledge of Allegiance.

Members present: Mayor Johnson, Trustees Graham, McMartin-Eck and Lauer. Trustee Sargent was absent.

Mayor Johnson gave a brief update on the meeting he and Deputy Mayor McMartin-Eck had with the Police department on Sunday, September 17th. It was determined that they would need to come up with a job description for "Officer-in-charge" per Civil Service. Officer Retzlaff informed them that he was not willing to serve as Officer-in-charge though he was senior officer.

Mayor Johnson said he has been trying to contact Genesee County Sheriff's regarding whether the Village can use them for confiscated evidence. He added that once the Police garage/locker room is set up there is one set of lockers with a double row of lockers that could be used for evidence with the Officer in charge having the key.

Trustee McMartin-Eck informed the Board that she had found key code locks with fingerprint ID for the police office at Home Depot for \$150 each. With these each officer would receive a code which can be removed if someone leaves. Trustee Graham suggested also getting them for the Maintenance buildings.

Motion was made by Trustee Graham and seconded by Mayor Johnson to approve getting two key code locks for the Police and two for Maintenance from Home Depot at \$150 each.

Trustee McMartin-Eck said she also got quotes for blown-in insulation for ceiling and fiberglass for inside walls of the Police garage. She presented a quote from Mike Ditzel at \$9,500 and one at \$9,676.97 from James Gayton Enterprises. She informed the Board that the third party that was contacted didn't want to submit a quote as they couldn't do it at those prices. It was also mentioned that this does not include the heating system.

Mayor Johnson mentioned that snow comes in the vent in the ceiling so that would have to be looked at as well.

Some discussion took place regarding other equipment and items needed by the Police such as vests for the new officers and tourniquets for all the officers. Trustee McMartin-Eck said the tourniquets have been ordered at \$23.00 apiece. It was also questioned if Deputy Clerk Beal had gotten set up for individual emails for each of the Officers and Trustees so Village business would not be on their personal emails. Clerk said she would check with Deputy Clerk Beal.

Trustee Graham questioned if reinstated Officer Cameron Leight is certified. Mayor Johnson said he still needs to pass his physical and has one year to get squared away.

It was also mentioned that Officers needed badges and IDs. Trustee Graham said all employees should have an equipment check list. Mayor Johnson said he will call Sheriff Brewster regarding ID cards.

Trustee Lauer questioned if the Board was going to finish addressing the Police building.

Motion was made by Mayor Johnson and seconded by Trustee McMartin-Eck to approve having the Police garage insulated as by Mike Ditzel per his estimate, not to exceed \$10,000.

Officer Anthony Bartucca arrived at the meeting at 7:20 pm and signed his Oath of Office and the DCJS form. Officer Pete Scanio arrived at the meeting at 7:26 pm.

Officer Bartucca said he wanted to address the Board about possibly bringing his K-9 on board to be used only by Corfu and not in mutual aid situations. It was mentioned that as a part time officer he would be limited to 19.5 hours per week. Officer Bartucca mentioned that is 19.5 scheduled hours. If he gets called in for a K-9 search, the additional hours are acceptable from his past experience.

Officer Bartucca gave an example of a stop they had on the last concert night involving a BMW that was stopped for going 53 mph in the 35 mph zone. He was leaving the concert venue only 1 hour after the concert had begun. It was observed that the driver had large wads of cash in several locations as he pulled out his driver's license and got his registration out of the glove compartment. It was mentioned that if they had the K-9, according to a Supreme Court ruling the dog would legally be able to do a "free air" sniff around the perimeter of the vehicle and if the dog detected drugs, the officer then has the right to search the vehicle without a search warrant. If any proof

of drugs were found the vehicle and cash would be subject to confiscation by the Village. It was added that Officer Scanio just had a drug stop this evening.

Officer Bartucca also mentioned that through some informants in both Buffalo and Rochester he was informed there are drug dealers in the Corfu area where concert goers often stop on the way to concerts.

He also mentioned that in just one shift he had counted 76 semi-trucks passing through Corfu. He said the average officer does not like to stop the 18 wheelers as there is a lot more paperwork involved. He said 18 wheelers often are used to transport drugs and gave a couple of examples of his experiences.

Some details on responsibility were discussed if the Village were to take on the K-9, such as vet bills, food etc. Officer Bartucca said he would be willing to donate his K-9 equipped Tahoe to the Village. It was questioned if converting the Explorer to a K-9 vehicle was feasible. Officer Bartucca did say that a dedicated vehicle would be needed due to the dog smell and shedding hair, which other officers would not want to put up with.

Mayor Johnson said he was informed that by adding the K-9 the liability insurance doesn't change as he is treated as an additional Police Officer. If the Village were to consider bringing on the K-9, an agreement would need to be drawn up including designating responsibilities and it would need to be reviewed by the Village Attorney. Officer Bartucca mentioned that the K-9 Rocco's certification runs out in 60 days and was hoping a decision could be reached with enough time to get Rocco recertified.

Mayor Johnson said he will confer with Sheriff Brewster regarding verbiage to look at for an agreement and would work on getting it put together by the next Board meeting on October 9th. In the meantime Officer Bartucca said he will put together all the file paperwork for Rocco's (K-9) file.

Officers Bartucca and Scanio left the meeting at 8:15 pm.

Trustee Lauer questioned the Board if leasing the K-9 vehicle from Officer Bartucca just to and from work and while on duty would be an option.
