and would like to continue the practice. The rest of the Board agreed.

Trustee Graham informed the Board that a pump at the Main Lift Station had to be changed out and rebuilt. He said the next meeting for the sewer project had not been set yet but he would keep the Board informed.

Clerk requested the Board set up Budget meeting dates. It was agreed that Budget meetings would be held on Monday January 21st, February 4th and 18th, and March 4th. Clerk will advertise the meetings. It was also agreed to send a letter to Judge Alexander for budget figures. Police and Maintenance have already been contacted to put together budget requests.
