

Village of Corfu Regular Meeting Minutes and Village Hall Meeting November 9, 2022

The Village of Corfu held its Regular Meeting and Village Hall Meeting on November 9, 2022, at 6:30 p.m. at located at 116 East Main St, Corfu NY 14036. In attendance: Mayor Sargent, Deputy Mayor Doktor, Trustee Lauer, Trustee Reisdorf, Village Clerk, Jennifer Eck, Village Electrician, Norm Waff, Code Enforcement Officer, Robin Johnson, John Hinman from MRB Group.

Planning & Code Enforcement Update:

 Mr. Johnson discussed the can redemption project that will be located behind Brittany's Booze Barn; planning board will review at next meeting 11/29/22. Mr. Johnson and Mr. Zimmerman are planning a walkthrough of this project.

Police Update:

• Mayor Sargent updated the Board on department, they have scheduled for more overnight shifts

Court Update:

- Received \$29,792.00 from court fines for October 2022
- From June 2022 November 2022 received \$186,000 in fines from the court.

Maintenance Update:

- Mr. Waff recommended sealing of pavement at plant be moved until spring 2023
- Mr. Waff has access to a Christmas tree for \$60/ 12 ft tree
- Door at plant #2 has been fixed
- Mr. Waff put a sign on man door in Police garage to contact Clerk if issues with door
- Deputy Mayor Doktor contacted CSX for the tree issue at Genesee Heights; waiting on return call.
 Drave's tree service is going to give a quote to Genesee Heights to present to CSX as this is their trees.

Norm Waff's Report - Maintenance Progress

CARRY OVER ITEMS:

1 Lock on the Police Garage man-door. Anti-tamper device will be installed when the issue of keys not working for some of the officers is resolved.

A message has been posted adjacent to the man-door asking the Officers to advise the Village Clerk if they have any problems with their keys working.

<u>2 What is the status of this item?</u> the installation of the concrete walkway behind the Police Garage?

<u>3 What is the status of</u> arranging to have blacktop driveways sealed at the WWTP. The last time they were sealed was before the Corfu 2 plant was started construction. The blacktop is showing signs of deterioration and will start to break apart. Sealing will extend the life of the driveways. Has the Village had any call backs from contractors to have this work done?

At this point in the season, I would recommend that the village wait until spring weather is here prior to getting this work completed.

4 The inside of the Clarifier Building has been pressure washed by Camden. In the next couple of weeks, I will be opening and cleaning the lighting fixtures and will be doing a group re-lamping of the fixtures.
 The Clarifier Room light fixtures have been cleaned and re-lamped.
 One fixture will be replaced in its entirety in the next few weeks.

5 Status Update? The door of the Influent Room at the Corfu 2 WWTP is still not latching and now the door is binding on the threshold. As a result, the door closer doesn't have enough power to close and latch the door. This continues to be a life safety hazard. This was scheduled to be repaired on 11/07 which did not happen. Has any documentation been received from the Town of Pembroke that they have accepted the Corfu 2 plant as complete? THE DATE OF THIS DOCUMENTATION DETERMINES WHEN THE WARRANTY PERIOD BEGINS.

- 6. Splash Block installation has begun. A rain leader in the Clarifier Bldg is damaged and is in need of repair. This will involve 3" PVC pipe and fittings. This will be done before the severe weather begins.
- 7. The new key type lock on the Police Garage man-door doesn't cover the hole previously made for the electronic lock. I will be installing a stainless-steel cover plate to rectify this. This work will be completed when the issue of keys not working for some of the officers is resolved
- 8. RustKote has been contacted to rustproof the vehicles. Awaiting a return call to schedule. **This work was completed on Monday, 10/31**

New Items:

- 1. Christmas Tree for the "Tree Lighting Ceremony" on Main Street.
 - I've got a friend that will sell the village a 12' tree for \$60.00.
 - We'll have to have a tree stand welded up to be mounted on one of the concrete sign bases.
 - I thought it would be great if the village residents to either make or buy an ornament to be placed on the tree.

Office Update:

- Received 3rd Quarter 2022 Sales tax distribution from Genesee County \$36,130.09
- Board in attendance signed the Affidavit of Village Collector and list of unpaid property taxes
