

Village of Corfu Regular Meeting Minutes November 10, 2021

The Village of Corfu Mayor and Board of Trustees held the Monthly Regular Meeting at the Corfu Village Hall, 116 East Main Street in the Corfu Fire Dept meeting room on November 10, 2021, at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Doktor, Trustee Lauer, Trustee Johnson, Trustee Reisdorf, Village Clerk, Jennifer Eck. Also in attendance, Norm Waff, Village Electrician, Glenn Eck, Camden Group Representative and 2 residents which didn't sign in.

Planning/Code Update:

- Burning Barrel BBQ has been approved by planning board; all information has been sent to Genesee County Planning Board which will meet on November 10th.
- Brittany's Booze Barn waiting on liquor authority and will start working on the inside of the building in upcoming weeks
- 9 West Main Street owners have been in contact with Mayor Sargent, they will complete the sidewalk repair before winter.

Police Update:

- Mayor Sargent needs to review parking ordinance for the department
- Trustee Lauer requested the Police Department change some shifts to early morning.

Court Update:

- Court audit has been sent to NYS Unified Court System.
- Received \$29,579.00 for October 2021 fines.

- Door for maintenance shop is painted, ready for install.
- No delivery date on new trailer.

- Cut off time for leaf pickup is Thanksgiving after, all leaves will need to be bagged.

- Village Clerk has submitted the affidavit of unpaid taxes to Genesee County Real Property
- Village Clerk has sent the unpaid sewer accounts to Town of Pembroke for relevy.
- Received \$34,415.50 for 3rd guarter Sales tax/Rounding adjustment from Genesee County
- Dillion and Shane Hale are working on website and emails
- Village Clerk has completed QuickBooks course; Deputy Clerk to finish within the next week.

Sewer Update:

- Trustee Reisdorf stated he reached out to Camden Group Regional Manager; Mr. Graham had stated the new plant is working at 95%.
- Mr. Eck has completed 3 presale inspections for sewer
- Mr. Eck questioned presale inspections for sewer in Genesee Heights, as there is nothing to inspect; it was decided this is not required
- Mr. Eck would like to purchase shelving units for spare parts for plant

- Discussion about grinder pumps for District 1; department had to replace one behind Sprinkles and have 1 left for repairs; Board requested to verify it is the responsibility of the sewer to replace, check on supply chain and cost to determine how many to keep in stock. Village Clerk will email Town to review the resident/Town contract.
- Mayor Sargent informed the Board the Force Main is off the table for the Town.
- Mayor Sargent would like to Ken Scherrieble to review all lift stations for added capacity and infrastructure bill.
- Trustee Lauer would like to discuss the \$34,000 in funding from Federal government; Trustee Lauer would like to pay down the bond or repair Depot Lift Station.

Beautification Update:

- Deputy Mayor Doktor is researching fundraising ideas for 2022 and indoor market ideas.
- Removed all flowerpots
- Mayor Sargent is planning a Holiday Parade scheduling for Friday, December 3rd @ 6:30 pm; route will cut through parking lot instead of turning onto route 77. Approx. 20 trucks have signed up to date.
