



Village of Corfu Regular Meeting Minutes November 18, 2020

The Village of Corfu Board of Trustees held the Monthly Regular Meeting at the Corfu Village Hall, 116 East Main Street on November 18, 2020 at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Trustee Doktor, Village Clerk, Jennifer Eck, and Camden Group Representative, Glenn Eck, Electrician, Norman Waff.

Mayor Sargent opened the meeting at 6:30pm followed by the Pledge of Allegiance.

Planning Update:

- Discussed the need for Brian Schollard is inspect all changes made to David Jackson's property; was never completed before sale of property from Mr. Williams
- Moving forward with Mr. Jackson's property with the Zoning Board of Appeals; Mayor Sargent insists on no Certificate of Occupancy until Mr. Schollard has inspection completed and approved

Police Update:

- Mayor Sargent discussed to collaborate with members of the Community and Police Dept to institute a task force to create policies advised by NYS
- Discussion regarding the Police vehicles, i.e. cost to value, repairs, state of the vehicles
- Mayor Sargent presented the Memo of Agreement with Police Department; discussed and reviewed with Board memo:

MEMORANDUM OF AGREEMENT
BY AND BETWEEN
THE VILLAGE OF CORFU
AND
CORFU POLICE LOCAL 9110, COUNCIL 82

WHEREAS, the Village of Corfu and the Police Union, Local 9110 wish to enter into an agreement as to the rights for filing vacancies by any previous employee of the Village Police Department, who has resigned as a member in good standing from the Village of Corfu Police Department;

WHEREAS, the Village and the Union have met and have established the following procedure for rehire opportunities for previously resigned employees and hereby agree to the following:

1. If an employee resigns from the Village of Corfu Police Department and wishes to be considered for rehire at a later date, he/she must have resigned in good standing with the Village of Corfu.

2. Both parties agree that a member resigning in good standing shall mean; one who at time of resignation has fulfilled his/her duties and obligations with the Village in accordance with the Village of Corfu rules and regulations and the resignation IS NOT as a result of pending or proposed disciplinary action.

3. The Village agrees that an employee who resigns in good standing, and later applies for an opening within the Village Police Department and who meets all qualifications and criteria established by the Village of Corfu and the State of New York for a Police Officers' position, shall have the right of first refusal for said position; provided the employee will and does commence work in said position within five (5) years of the effective date of the employee's resignation.

4. Both parties agree that, should there be more than one candidate qualified, but only one vacancy, the most senior person at time of their resignations with the most continuous service with the Village of Corfu, shall be chosen as long as he/she has met all criteria and qualifications necessary to fill the position that is vacant.

5. Any employee rehired pursuant to this Memorandum of Agreement shall be considered a new hire for all purposes including wages, benefits, and seniority as of the date they commence employment upon being rehired.

6. New hire wages are determined at time of rehire by the hiring committee and take into consideration experience and years of service.

Both parties have been fully represented in this matter and said agreement shall be in effect upon signing and can only be changed or altered by a writing between both parties.
