

Village of Corfu Regular Meeting December 4, 2019

The Village of Corfu Mayor held its Monthly Committee Meeting at the Corfu Village Hall, 116 East Main Street on December 4, 2019, at 6:30 p.m. Present were Mayor Sargent, Deputy Mayor Graham, Trustee Lauer, Trustee Reisdorf, Village Clerk, Jennifer Eck, and Glenn Eck. Trustee Doktor was absent.

The meeting was opened at 6:30 pm followed by the Pledge to the Flag.

Police Update:

- -The Mayor informed the board that the computer update has been completed in the new police vehicle and it is in service.
- -Received check in the amount of \$5,500 from Delacy Ford for the trade in value of the Ford Explorer.
- -Discussed the police department would like to use the money received from Delacy Ford to repair the dents on the Taurus and add the new decals the Taurus, to match the new Explorer. Decided to revisit this topic in the spring.
- -Mayor Sargent spoke with the Union regarding comp time; he will speak with Melinda on the addendum to contract
- -The police department attended "Stuff the Cruiser" in Batavia; great turnout, the SRO's are coordinating with local schools to evaluate the needs for families
- -New police vehicle attending the Lancaster fire parade
- -Deputy Mayor Graham requested the Board meets all new officers

Planning Update:

- -Sidewalk at 37 West Main has been replaced from homeowners
- -Trustee Reisdorf will reach out Mr. Schmeigel regarding his property to discuss possibility of rezoning
- -Mr. Eck discussed with the Board the Village property on Depot Street; approx. 2 acres of land and would like the Village to look into an idea of creating a park for residents; Deputy Clerk will research grants

Court Update:

-Audit has been completed; Dave Saleh is creating the final report to present to the Board with recommendations

Maintenance Update:

- -Mr. Eck and Mr. Waff replaced lighting in the parking lot at Sewer Plant and Police Garage
- -Tree limb broke off tree on Main Street during the last wind storm; will cut entire tree down
- -Maintenance dept trimmed trees over sidewalks

Office Update:

- -Village Clerk presented Board with the CFA Application and WIIA Grant from MRB
- -Village Clerk updated Board with Cyber Security Insurance quote through Lawley insurance; premium

is \$1000 per year; Clerk will speak with Nick to inquire on a policy.

- -New computers shipped today; will be installed after New Year
- -Village Clerk presented Board with quote for color copier/printer with WNY Imaging; same price as current copier/printer; WNY Imaging will waive any fees; price will be \$128 per month for 36 months

Deputy Mayor Graham made a motion to lease the stand-alone copier through WNY Imaging in the amount of \$128 per month; 2nd by Trustee Reisdorf.
